## "Helping to Make Radyr & Morganstown a Great Place to Live!"

In this, our first Annual Report, Councillor H Onllwyn Jones, Chair, Radyr & Morganstown Community Council 2021/22, looks back on a difficult year for our local community and anticipates some of the challenges ahead.

Working within and alongside our community, we have come through difficult recent times. It is wonderful to see our community coming back to normal, following the pandemic and the restrictions we have all faced.

I wish to record the Council's appreciation of the efforts of so many volunteers, individuals and organisations who have helped sustain the community during unprecedented times.

I am pleased to say though that, as far as possible, the Council continued to function and serve the community. We funded projects, delivered services, held meetings remotely and worked with our partners to provide safe and vibrant communities for us all to all enjoy. Our Christmas lights and other festive initiatives brought much needed seasonal cheer, encouraging and welcoming visitors.

Radyr and Morganstown is well-supplied with houses and homes but with small and compact community centers, such as Station Road, the onus is on ourselves, much of the time, to create our own community spirit.

The community has always risen to this challenge with energy and enthusiasm.

I am especially pleased to take this opportunity to pay tribute to the work of the long established Radyr and Morganstown Association that works so hard to provide a wide range of events whilst also raising a substantial amount of money for charity. We have pleased to support the Association by helping to stage an annual festival each year. I am sure that this will continue.

We look forward to developing and strengthening our relationship with new Chair Tom Evans and his team during 2022/23. We are always keen to develop good relationships with community, such as our wonderful team of litter pickers who we have supported and our local clubs, uniformed organisations and societies. We have helped our local scouts fund improvements to their premises over the years.

We have some amazing clubs in our community, such as Radyr Golf Club, which we have supported with grant funding to help them develop golf lessons for young people and Radyr Cricket Club, which has also received Community Council funding. We also have an excellent local tennis club.

We take a very keen interest in Cardiff Council's proposals to create a replacement Local Development Plan.

New developments have already put pressure on the local infrastructure and we now await with interest to hear if more housing can be expected in areas such as land to the north of the golf club (alongside Pant Tawel Lane) and near Radyr Station. We are interested to see how development of land near the station will impact on access to public transport.

Other important developments include a new District Centre which is proposed for land just south of Llantrisant Road and the potential establishment of a new public house at

Maes-y-Llech farm. These developments will add to the local economy but also bring commercial pressures for existing enterprises and concerns over issues such as traffic for residents. We are pleased to see local businesses such as the Radyr Tap going from strength to strength. We also remain concerned at the condition of Drovers Way playground, which has experienced drainage problems for many years.

The Council met with Cardiff Council officials in November 2021 to walk the area and discuss if and how it could be improved to better serve as the heart of our community and to better manage traffic. We look forward to working with the leadership of the Council and a continuation of this dialogue. Our relationship is underpinned by a Charter.

It is important that the Council continues to act as a voice for its community, drawing on appropriate expertise to articulate any concerns as these developments and concerns come forward. We have also worked on behalf of residents to try to overcome other issues of local concern, such as the future of Bethel Chapel, a new bridge at Morganstown and signposting of local areas of interest.

Our premises at the Old Church Rooms continues to serve a wide range of community groups and we are looking at proposals to improve the premises to help benefit the community. We continue to manage Radyr Woods and have helped with the installation of a new storage compound for safe storage of equipment. We have also helped refurbish Pentwyn Park and will look at potential improvements to improve Windsor Gardens.

So that is just a glimpse of the work that the Community Council has undertaken recently and some thoughts on forthcoming issues.

Our hardworking Members manage a small budget to serve the community, promoting a bilingual organisation at the heart of the community. I am proud of our achievements. We have responded to global pressures which have impacted on our community. We will continue to embrace digital solutions to work alongside our community and keep residents informed of our work.

We have also stood alongside the people of Ukraine in the crisis which developed there towards the end of 2021/22. Radyr & Morganstown Community Council stands in solidarity with the people of Ukraine. We strongly condemn the country's invasion and mistreatment of its people. We call upon the international community to work together for peace in Ukraine and the maintenance of an independent and democratic Ukraine.

I wish to record my thanks to our diligent staff and look forward to working with our new Clerk, David Collins in 2022/23.

Finally, the Council wishes to place on record its appreciation to Clive Morgan and Rod McKerlich for whom 2021/22 has been the final year of office. Both have served the community with distinction

The Council will continue to embrace principles of Sustainable Development based upon Long Term Planning, Prevention, Integration, Collaboration and Involvement to deliver these goals.

#### **Statement of Well-being**

This Well-Being Statement sets out the Council's commitment to the principle of sustainable development to ensure that the needs of the present are met without compromising the ability of future generations to meet their own needs.

The Well-Being of Future Generations (Wales) Act 2015, 'the Act', defines sustainable development as the process of improving the economic, social, environmental and cultural well-being of Wales by taking action, in accordance with the sustainable development principle, aimed at achieving the well-being goals. In this regard the Council recognises the role it has to play. Therefore, it will promote sustainable development in how it goes about meeting its duty under the Act and when working for and with the communities that make up its area.

The Act puts in place seven well-being goals. These well-being goals are indivisible from each other and explain what is meant by the well-being of Wales. The Council embraces these well-being goals and will place them at the heart of its forward planning and decision-making arrangements to improve the general quality of life (well-being) within its administrative area. The Act provides a more detailed definition for each of the seven well-being goals. However, for the purposes of this statement the seven goals are:

When applying these well-being goals to the functions, activities and services provided by the Council; the Act requires the Council to think more about the long term, to work better with people and communities and also other public bodies, to look to prevent problems and to take a more joined up approach.

# COMMITMENTS


- Look to the long term so that its actions or lack of action does not compromise the ability of future generations to meet their own needs.
