County Councillor Information Update

Introduction

1. This report provides general information on recent matters of interest to the Radyr & Morganstown Community arising from the work of Cardiff Council.

Key Issues

2. Issues reported by Councillor Calum Davies include the following:

Drover's Way Park

I am delighted that underlying drainage works has finally commenced, paving the way for a new, refurbished park. This work should be completed by the end of June – should there be no delays – and construction on the playground is scheduled to follow imminently, taking three months to complete. Whilst I had initially hoped the park would be in place for summer, that we have now broken ground is a major milestone meaning the community will have the park it has been promised sooner rather than later. This was not the achievement of any one person and I thank all those who have played their part in getting the project this far.

Budget

The Council has raised Council Tax by 3.95% for the coming financial year. I opposed this on the basis that it has already gone up by around 50% since 2012, when Labour won control of the Council, through above-inflation annual increases on a regular basis. I spoke in favour of a Conservative amendment that would have seen a Council Tax freeze this year without cutting frontline services. We also called for black bin bag collection to remain at a fortnightly basis as they are threatened with moving to three-weekly. Our proposal, should it have passed, also meant keeping St David's Hall in Council hands for the following year. However, as part of my

committee work, I was pleased to see that budgets schools and children's services are much improved, as they should be.

Radyr Rangers

Cllr Lloyd Jones and I met with representatives from Radyr Rangers, Transport for Wales, and Cardiff Council to progress moves towards a club house on Mound Field. We are hoping there will be an engagement process with stakeholders soon that will allow the organisations to get an idea of what the community think of potential proposals that are still being devised.

Gelynis Farm Bridge

I met with Cardiff Council officers and Transport for Wales to hear more about the proposed bridge over the railway at Gelynis Bridge. The bridge is necessary to provide road, foot, and cycle access with the existing right of way being reconfigured to work around the increase in rail services on the lines. My main concern has always been over the gradient of the bridge and whether it is compatible with equalities law and making it accessible to wheelchair users. I continue to monitor the situation.

23/00320/PRAP proposal for 15m 5G mast on Heol Isaf/Min y Coed junction

The application regarding a 5G mast on the junction when Min-y-Coed meets Heol Isaf was refused for a second time. For your information, the applicant can either appeal the decision or submit an alternative application in an attempt to overcome the Council's concerns. This could be an alternative site, reduced height of the mast, etc. but it will be for the applicant to decide how they wish to progress this. A few residents had said it would be preferable for the mast to be sited the other side of the road. However, this may prove problematic due to tree coverage and the lack of space given the ravine there. I have myself suggested an alternative location down the road out of view of homes.

Waste collection

Garden waste collection has restarted on a fortnightly basis residents will be glad to note. However, I have received negative feedback on the rolling out of the new recycling regime in the ward. If you have any issues, do let me know so I can report this to the Council and scrutiny committees. The new regime would see the end to green bags with mixed recycling and the introduction of multiple caddies and bags for separated recycling. This is to improve recycling rates, but I am concerned that this will actually have the opposite effect. The scheme is being rolled out incrementally so some properties will already be subject to the new regime, while others are not.

Ralph Vaughan

I was saddened to hear about the passing of community councillor Ralph Vaughan. Ralph had been a stalwart of Radyr & Morganstown for many years and I know just how much people in the area will dearly miss his dedication as well as the story he always had up his sleeve. The large crowd at his funeral is testament to his many years of dedication.

Written Questions

Ahead of every Council meeting, I have the chance to table five written questions to the Cabinet. I will aim to use up my allocation each and every month to find out information useful to myself as a representative of Radyr & Morganstown but also in my other roles on the Council, including Shadow Cabinet Member for Supporting Young People and Tackling Poverty. This month I asked:

- 1. When will drainage works begin on Drover's Way Park and when will the works begin on refurbishing the park?
- 2. How will the Council assist Cardiff Bus in preserving routes and service frequency with the Welsh Government's Bus Emergency Scheme due to end in June 2023?
- 3. What assessment has the Council made of the contribution of cycle lanes to road congestion and what data has it collected on the use of cycle lanes over the last five years?
- 4. What action is the Council taking to assist Radyr Rangers in securing a lease for Mound Field and what timelines can it outline for completion?
- 5. What progress has been made in tailoring the new recycling regime to those who live in HMOs, apartment blocks, and properties converted into flats?

Playground Drovers' Way SECOND PRIORITY

Lights in Drovers Way via the Playground towards Plymouth Drive

The Parc Radyr Management Company is still waiting for a final figure for an estimate for lights. Once this is received the PRMC will look for funding.

Pavements

Please let me know if there are pavements you feel badly need attention.

Streetlights at the top of Brynderwen start of Drysgol Road

Last time I checked there were three lights not working. I understood that the cable had been broken in many places, but I don't understand why the job has not been completed. Will continue to ask.

Plasdŵr

Completing the road surface for Lon y Pererinion

This I suspect is probably linked to the work that needs to be done in St Philberts. It's becoming obvious that Redrow don't want to come in and do one job and then return and do similar work with the same equipment in another street. In the meantime, we have residents with osteoporosis who dread driving out of the street.

Odour at Clos Parc Radur

Have now gone a month with no complaints.

Mobile Library The mobile library is supposed to be coming to Parc Plymouth, still no firm date yet.

St Philbert's

Attenuation Tank

Discovered that a planning application has gone in for a new design for the tank.

Turning points for Bin Lorries

This has come up since March. I have raised the issue.

Community Engagement Worker

Would love to get funding for us to have a Community Engagement Worker in Plasdŵr. Had one grant application turned down last week but will continue to look. If anyone knows a possible funding source, please let me know.

The Sidings

Sadly, there was a horrible accident on the bridge as you enter The Sidings. I have been down and looked to see if there is an obvious solution that would prevent another accident. Remember that speed bumps installed in an area I lived in before I moved to Radyr were hated by older people and did not deter those who loved going fast. In fact, they would deliberately go fast over them to get that G force feel.

Know that many of you cycle along the old cart road between the river and the supporting wall for the City Line down to Danescourt. Have noticed that the river is eroding the bank in several places. Investigating at present but think the landowner is Taylor Wimpey and the responsibility for the riverbank is either Taylor Wimpey's or Natural Resources Wales.

The maintenance men working in De Clare Drive on the communal space advised me they were making things good ready for the Council to take over. Have not had any information from the Council on this at all but will ask.

Think the way forward will be to work out the extra costs that will arise if there is no bus service, and the impact on lowering our carbon footprint.
