### **Meeting with Leader of Cardiff Council 21 September 2022**

#### **Introduction**

1. This report updates Members on progress in relation to the above meeting. The issues discussed primarily related to environmental and planning concerns though some additional matters were also discussed.

#### **Key Issues**

**Background:** *Members of Radyr and Morganstown Community Council have invited Cllr Thomas to visit our community to discuss matters of interest to our residents and Members. It has been a long-standing wish that Cllr Thomas might be able to visit us and meet our Members.*

### **Suggested Agenda/Items for Discussion:**

#### **1. Station Road**

This is Radyr's mixed-use commercial area which meets an important community need in the heart of Radyr.

Unfortunately, this street needs an injection of vibrancy and a refresh. One of the largest units (formerly the Spar) is now empty and has been for quite some time. Our post office is housed in McColl's General Store but has been hampered by staffing issues and its opening hours are unreliable. The same is true of our local pharmacy.



We do have three “refreshment units” (The Radyr Tap, Slice & Cicchetti's Restaurant) which attract many of our residents.

Ideally, we would like this area to resemble that of Llandaff's main shopping street and/or that of Wellfield Road.

We have received a visit from officers of CCC where we discussed parking, street furniture, enhancement of pavements, the potential for a one-way gyratory system, greater safety measures in the surrounding area (such as zebra crossings near the Station and possible closure of the junction at King's Avenue).

We would be very interested to learn of any options which the local authority might be contemplating to breathe new life into this important location.

Of course, appropriate consultation and the views of residents will be important.

## 2. Windsor Gardens

Windsor Gardens provides an important area of green space within a largely urban setting. Like Station Road however, it may be timely to look at the prospects to refurbish the site. New planting, landscaping and play equipment may be appropriate. Again, we would be interested to hear about any options under consideration for the gardens.



Just to note that this area is owned by CCC but RMCC manage and are responsible for the upkeep of the park.

## 3. Drovers Way Play Area

Following flooding of February 2020 this children's playpark has been out of use – indeed its equipment has been removed.

We have good relations with the Parc Radyr Management Committee and have supported their attempt to get the park repaired and equipment reinstated, e.g. we have awarded a grant of £5,000 for new play equipment which we understand is held by CCC.



We are aware that there is currently a tender process currently taking place that should see the park made good and would be interested to receive an update on this process.

#### 4. Bethel Chapel

The condition of this site in Morganstown has been a long-standing cause of concern to local residents. We would be interested to discuss any influence which your Council could bring to achieve any improvements. We understand that action can be taken to enforce against unsightly premises in extreme circumstances. The Clerk to our Council has raised the matter the Head of Planning.



#### 5. Active Travel/Public Transport

Our Members are very interested in proposals to improve active travel locally. We would like to hear your views on any proposals to improve active travel in our community and any proposals to introduce cycle paths. We are also keen to see improvements to the local bus service.



## 6. Census 2021 and the Replacement Local Development Plan (RLDP)

We would welcome clarification on the Census results and the Council's projections for local population growth which we understand to show projected growth as slower than anticipated. Presumably this will mean that we shall not need to plan more as many houses as previously thought.



As a Council we also have other issues regarding the RLDP, particularly the two candidate sites – i.e. the one near Rhydlafar and the other on the Station Car-Park at Radyr.

As a Community Council our position is that we believe our area of Cardiff has lost so much land to the initial LDP and that the further loss of these two sites would be unfair and unnecessary.

We would prefer that the sites already granted are fully developed, along with the “Garden City” facilities that were promised. We are also mindful of the burden any further developments would place on local roads and services.

Whilst the RMLDP Group will later focus on the candidate site at Rhydlafar the Community Council would be very disappointed to lose the station carpark.

This carpark helps keep car from our city centre and encourages train travel. It is an area that is well used by the community, not just to park their cars but also in the following ways:-



- *It is used by walkers and runners as a meeting point*
- *It is used by people to meet up and socialise in the open air*
- *It is used by young people to skate and play games*
- *It is used on a weekly basis to provide Thai Meals from a mobile kitchen.*
- *It is used by young drivers to experience driving a car for the first time.*
- *It is used by a local keep fit group.*

## 7. Old Church Rooms

This is the home of the Community Council and aside from the schools is the largest public building in our area. We are seeking to make it a 21<sup>st</sup> century building and are currently exploring the following potential enhancements: -



- *Installation of a lift to ensure access for all.*
- *Conversion of a downstairs store into a ground floor meeting room.*
- *Building a replacement outdoor store.*
- *Making the outside more attractive.*

We would appreciate any advice you can give us on access to Section 106 monies and grants that might help us with this process.

## 8. Young People

The Community Council has a Young People's Working Group and some of our thoughts can be found below. Areas coloured in red are where we would seek the support of the CCC.

<p><b>All Young People</b></p>	<p>Make OCR available for clubs and events that may be enjoyed by young people of all ages.</p> <p>RMCC should support local clubs who provide activities for our young people through support/grants.</p> <p>Help ensure the facilities afforded to Radyr Rangers at Mound field is appropriate and as good as they can be.</p>	<p>RMCC should ensure its rooms are available and adequately equipped for such groups and it should advertise its facilities for events such as children’s parties etc.</p> <p>As left – particularly regarding Radyr Rangers, Cardiff Corinthians, Radyr Cricket Club, Radyr Tennis Club and Radyr Golf Club etc.</p> <p><b>RMCC needs to work with CCC, Radyr Rangers and TFW to achieve this.</b></p>
