172 Precept and Budget for 2018 – 2019

(iii) Proposed Budget for 2018/19

Chair of Finance Cllr Rod McKerlich gave an overview of the financial position of the council and the proposed budget, which had been discussed in detail at the Finance Committee meeting. Earmarked reserves were noted.

Members discussed the feasibility of financially supporting our young children with complex needs at Radyr Comprehensive through the Youth Services and CAMHS (Child and Adolescent Mental Health Services). Addressing and supporting this issue was a duty for Cardiff City Council. Cllr Rod McKerlich however suggested that he would raise the matter directly with the school and Governors in the first instance.

Resolved: Council agreed that band D equivalent dwellings remain at £32.87 per annum thus setting the annual precept at £121,915 for 2018/19 for Radyr & Morganstown Community Council.

(iv) Precept Notice 2018/19

The notice was completed in the presence of the Council confirming the agreed level of precept at £121,915 and duly signed by the presiding Chairman Cllr Ralph Vaughan, Cllr Rod McKerlich, Cllr Helen Lloyd Jones and countersigned by the Clerk.

173 Revision of the Financial Regulations

(i) Resolved: Council agreed to the revised financial regulations which separated the chair of planning and environment into two positions as opposed to one.

174 County Councillor's Report – December 2017 and January 2018

Cllr Rod McKerlich's written reports were received and noted and a verbal overview was received, which in summary included:

- 20mph signage at Bryn Deri and Radyr Primary School completion next month
- Windsor road awaiting signage

- Working with Mark Drakeford AM in relation to contentious Springfield Gardens planning application, which is to be determined at Planning Committee on the 7th February and Radyr Sidings on 7th March.
- Street lighting installation of residential LED lighting across Radyr commencing March 2018
- War Memorial refurbishment phase 1 has started (as per November 2017 report)

175 Community Councillors Reports

Cllr Huw Onllwyn Jones' report was received and noted. Cllr H Jones also gave a verbal overview which in summary included his work with Age Connect and the luncheon club alongside fellow councillor Cllr David Suthers, the OCR and external signage, drafting a new remit for the NWCG, preparing a paper re: Pentrepoeth v Treforgan.

Cllr Helen Lloyd Jones had attended a recent Arup meeting and also prepared a response to Cardiff City Council re: Planning Application 17/03034/MJR The Radyr Sidings

176 Treforgan v Pentrepoeth – this item was deferred from the last meeting

(i) Report by historian Mr Allan Cook was received and noted

(ii) Discussion Paper by Cllr Huw Onllwyn Jones was received and noted Following much discussion, including touching upon going to a poll, the Chair Cllr Ralph Vaughan suggested that Council awaits the paper by Professor Gwynedd Pierce which had been sent to the Welsh Language Commissioner.

177 Mark Drakeford AM

Mr Mark Drakeford AM thanked members for the invitation to attend their meeting. He was interested in the quality of papers received and in the advice received during the meeting in relation to the precept. A few questions were raised by members to which he responded; in summary::

- Welsh Government (WG) were powerless to do anything in relation to Tax breaks for landlords as this is dealt with at Westminster.
- In respect of reviewing Community & Town Councils roles & responsibilities, there was
 an enormous gap between the largest and smallest councils and some areas with no
 councils at all. With larger councils having ambition and resources, to the smaller
 councils having too small a precept to be effective. He also spoke on partnership
 working, competent councils, elections and apathy resulting in uncontested seats.
- Conducting a proper poll on the Welsh name of Morganstown would be giving the community a democratic voice in the decision making process.
- Money lost to Cardiff through the distribution of funding by WG to LA's in Wales is the fairest of processes based on need. Redistributing monies any other way would result in 4 authorities being better off with 18 being worst off.
- CIL (Community Infrastructure Levy) has not been adopted by Cardiff Council due to the County Council receiving more money from big scale developments through Section 106 as opposed to CIL, which is a more effective stream to develop infrastructure.

Chair Cllr Ralph Vaughan thanked Mr Mark Drakeford AM for his attendance and both left the meeting.

Vice Chair Cllr Huw Onllwyn Jones chaired the next few items in the Chair's absence.

178 Senior Citizens Luncheon Club Progress

A progress report by Mr Martyn Smidman, Volunteer Manager Age Connects (Cardiff and the Vale) was tabled at the meeting and noted. In summary, luncheon will continue at the Ty Nant for the next couple of months at least until a more private venue is secured thus introducing activities and speakers. More volunteers are required. Age Connects will support this initiative between 12-14 months, until viable.

Resolved: Council agreed that Cllr Myles Vatsaloo and Cllr Kevin Ullah join Cllr Huw Onllwyn Jones as volunteers on this project.

- 180 Cardiff County Council Standards & Ethics Committee Report of the Director of Governance and Legal Services An Monitoring Officer

 This item was received and noted.

Chair Cllr Ralph Vaughan returned to meeting and chaired the remaining items.

- 181 One Voice Wales Christmas letter from Cllr Mike Cuddy, Chair This item was received and noted.
- 182 Welsh Government Independent Review Panel Review of Community and Town Council Sector in Wales

Cllr Huw Onllwyn Jones agreed to draft a response to the four questions posed by the Welsh Government and would circulate his paper to members for further comments prior to responding to the Welsh Government.

- One Voice Wales Buckingham Palace Garden Party 15th & 31st May and 5th June 2018
 This invitation was to the current Chair and guest. Deadline for nominations: noon on 19th
 January 2018. Clir Huw Onliwyn Jones expressed an interest in attending.
- 184 IT Support

A report 'IT System Recommendations 'by Altodigital who undertook a thorough IT audit was received and discussed. Two further companies were invited to quote. Resolved: Council agreed that the IT installation and an annual maintenance and support contract be awarded Altodigital. It was suggested that the Clerk look at any portable IT devices/equipment that may be required to assist with her remote working.

- 185 Newsletter Cllr Tyrone Davies this item was deferred.
- 186 External Signage

At the Old Church Rooms Hall Management Committee meeting on Monday 8th January 2018, the clerk suggested external bilingual signage on the building, 'The Old Church Rooms' above the main entrance and 'Radyr & Morganstown Community Council' sign above the other (side) door. Resolved: Council agreed to fund up to £500 on external signage. It was noted that Clir H O Jones had been nominated at the OCR meeting to source the signs.
